

**OFFICIAL RULES FOR SPAVE®  
LEMONADE DAY SWEEPSTAKES**

**NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW.**

**Eligibility:**

This Sweepstakes is open only to legal residents of the United States, excluding residents of Florida and New York, who are at least 18 years of age at the time the sweepstakes begins. The Spave Lemonade Day Sweepstakes (“Sweepstakes”) is void outside the United States, or where prohibited or restricted by law.

This Sweepstakes is sponsored by Live. Give. Save., Inc. (“Sponsor”). All employees, officers, directors and agents and their immediate families or any members of their households, regardless of relationship, of Sponsor or Lemonade Day or any advertising agency or other company involved with the design, production, execution or distribution of this Sweepstakes or the Spave App are not eligible to participate in the Sweepstakes or to win any prizes. The information you provide to Spave in connection with the Sweepstakes will only be used in the event you are selected as the Sweepstakes winner.

Any Sweepstakes entries received from an ineligible participant will be disqualified. By participating in this Sweepstakes, participants accept and agree to be bound by these rules and the decisions of Sponsor, which shall be final on all matters. Sponsor reserves the right to modify the rules of the Sweepstakes in any way at any time, subject to state or federal law.

**Sweepstakes Period:**

The Sweepstakes begins on [March 8, 2024](#) at [9am CT](#), and ends on [March 14, 2024](#) and [5pm CT](#) (“Sweepstakes Period”). All entries must be received and recorded by Sponsor during the Sweepstakes Period to be eligible.

**How To Enter:**

You can enter the Sweepstakes through any of the following means between March 8, 2024 at 9am CT and March 14 5pm CT:

- 1 entry for every \$50+ donation to a nonprofit using the spaveNOW feature in the Spave app
- Gain an additional entry with a \$50+ donation to Lemonade Day using the spaveNOW feature in the Spave app
- 1 entry for creating a spave account/profile in the Spave app
- 1 entry for each Facebook or Instagram share, or tag of Spave, of your Spave app donation using #spavesxsw
- Gain an additional entry for each Facebook or Instagram share, or tag of Lemonade Day, of your Spave app donation to Lemonade Day using #lemonadedaysxsw
- 1 entry each when you follow/like Lemonade Day on Facebook or Instagram
- 1 entry each when you follow/like Spave on Facebook or Instagram

Multiple entries per person are permitted and will be considered for entry in the Sweepstakes.

Sponsor is not responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by the participant or by any of the equipment or

programming associated with or utilized in this Sweepstakes, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's computer system. Participant must notify Sponsor of any changed contact information within the Sweepstakes Period to remain eligible to win based on entry information. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar response methods will void all such entries submitted by such methods.

**Prizes and Selection of Winners:**

Sweepstakes participants will enter for a chance to win: (1) a \$1,000 daily drawing for all eligible entries received during March 8-10, 2024; and (2) one \$5,000 grand prize drawing for all eligible entries received during the Sweepstakes Period. The chances of winning depend on the number of entries received. No transfer, assignment, or substitution of any prize is permitted.

Winners of the \$1,000 daily drawings will be selected in random drawings on March 8, 2024; March 9, 2024; and March 10, 2024. The winner of the \$5,000 grand prize drawing will be selected in a random drawing on March 14, 2024.] Sponsor will notify each winner individually by email..

Winners must respond within five (5) [business days of being notified or the prize may be forfeited and another Sweepstakes participant chosen. Each winner must satisfactorily complete an affidavit of eligibility showing compliance with these Sweepstakes Rules, and a liability and publicity release, allowing Sponsor to use his or her information for advertising or other purposes. Failure to complete these forms may result in forfeiture of the prize. In the event that the potential winner is disqualified for any reason, Sponsor may select an alternate potential winner by random drawing from among all remaining eligible entries.

Winners are solely responsible for all applicable federal, state or provincial, and local taxes and any expenses associated with any prizes. The IRS requires Form 1099-MISC to be issued and filed for each recipient who received a prize/award if the annual aggregate is at least \$600 or more. Winners must complete and submit a W-9 form to receive any prize. The recipient is responsible for any income tax liability and should consult his/her/their tax advisor for the proper tax treatment of this income on his/her/their tax return.

Sponsor reserves the right, in its sole discretion, to modify, terminate, or suspend this Sweepstakes should viruses, bugs, unauthorized human intervention or other causes beyond Sponsor's control corrupt or impair the administration, security or fairness of the Sweepstakes. Sponsor is not responsible for any human or technological error that may occur in the processing of the Sweepstakes nor are they responsible for any error, omission, interruption, deletion, defect, communications line failure, theft or destruction of, unauthorized access to, delay in operation, transmission, or distribution of, or alteration of entries, whether caused by the sender, any of the equipment or programming associated with or utilized in this Sweepstakes, or otherwise.

**Limitation of Liability and Dispute Resolution:**

Except where prohibited, each participant and winner accepting a prize agrees that: (1) all issues and questions concerning these rules shall be governed by Minnesota law without giving effect to any principles of conflicts of law of any jurisdiction; (2) any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Sweepstakes or any prize awarded shall be (a) resolved individually, without resort to any form of class action; and (b) filed only in the state courts situated in

Minnesota, and participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; (3) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall include attorneys' fees; and (4) under no circumstances will any participant or winner be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
